2) In Person: You may bring your payment to the accounting office: 1765 E Harvester. Drop it through the mail slot by the door or deliver it to accounting personnel if present.

3) By Electronic Check: You may complete the attached form and use your checking, business checking, or savings account to make a one-time payment or authorize Pampa Country Club to debit your bank account automatically each month for the balance of your Pampa Country Club account. You may return the completed and signed form along with your Pampa Country Club statement stub in the envelope provided or **fax both to the Accounting office at 806-669-2761.**

4) By Credit Card: You may complete the attached form and use your Visa, MasterCard, Discover or American Express to make a one-time payment or authorize Pampa Country Club to debit your credit card automatically each month for the balance of your Pampa Country Club account. You may return the completed and signed form along with your Pampa Country Club statement stub in the envelope provided or **fax both to the Accounting office at 806-669-2761.**
